Children's Home and Aid's Adoption Preservation and Subsidized Guardianship Services

Difficulties can arise any time after an adoption takes place. These difficulties could include: attachment problems, behavioral problems, family adjustment challenges, adolescent identity concerns, mental health issues, and school problems. Children's Home and Aid provides services to adoptive families who are experiencing adoption-related difficulties. Services can include in-home and office based assessments and counseling.

All therapists have a Master's degree and receive on-going training in adoption related issues, including attachment work. Mental health advocacy services are available to adoptive families receiving counseling services through the program. Support groups and educational groups for children and parents are also available to provide families contact with others who may have similar feelings and circumstances. The following counties are served by Children's Home and Aid: Bond, Clinton, Jersey, Madison, Monroe, Randolph, St. Clair, Washington, and portions of Calhoun and Macoupin.

There is also an expanded respite program for families which includes regular weekly respite opportunities with a respite worker and other case-by-case respite opportunities. Adoption Tax Credits

The information below is not to be construed as legal advice. It is always advisable to consult a tax professional with individual questions.

Federal Tax Credit

Beginning in 2003, families adopting a child with special needs from foster care were able to access a federal adoption tax credit without needing to document expenses. For tax year 2007, the tax credit is over \$11,390 per child and parents have this year and up to the next five years in which to claim the credit.

How do I know if my child is considered to have special needs according to the IRS?

The North American Council on Adoptable Children (NACAC) interprets the instructions for Form 8839 (the Adoption Tax Credit form) this way: If you receive adoption subsidy (assistance) for your child, the state that provides the subsidy has determined that your child has special needs. Your adoption subsidy agreement (or application and agreement) is the evidence that the state has determined your child to have special needs. These instructions (found at www.irs.gov/instructions/i8839/ch02.html#d0e284) state:

A child is considered special needs if all three of the following statements are true:

1. The child was a citizen or resident of the United States or its possessions at the time the adoption process began.
2. A state (including the District of Columbia) has determined that the child cannot or should not be returned to his or her parents' home.
3. The state has determined that the child will not be adopted unless assistance is provided to the adoptive parents. Factors used by states to make this determination include:
 - A. The child's ethnic background and age,
 - B. Whether the child is a member of a minority or sibling group, and
 - C. Whether the child has a medical condition or a physical, mental, or emotional handicap.

If you check the box in column (d), indicating the child has special needs, be sure to keep evidence of the state's determination in your records.

FACC 2008 Training Extravaganzas: 7.5 Training Hours!

Thanks to the Daughters of Charity Healthcare Foundation of St. Louis, FACC will host the next Training Extravaganza on **Saturday, March 1st, from 8:30 a.m. – 4:00 p.m.** with theme **Family Strengthening through Gang Resistance Education And Training (G.R.E.A.T.)**. The Extravaganza is an all-day training that allows foster/adoptive/relative caregivers to receive 7.5 in-service training hours in one day, and you can bring the kids, too.
