Letter from the Board PresidentJoe Bergan

If a single theme emerged over the last year, it's this: Connection is everything.

When we're uncertain, alone, or afraid, we look to our families for support. But for our kids, for kids in foster care, who can they look to?

The last year was an important reminder that there are children right here in our community for whom loneliness and uncertainty are not the exception but the rule. The feelings we all struggled with were only a glimpse of what they go through. After all, just as important for a child as food, water, and shelter is an often overlooked basic need: Family.

In 2019, we celebrated our 30th anniversary as an innovative, agile leader in ensuring every child in foster care has a home to help them heal. In 2020, we realized it has taken us those three decades to prepare for the present moment. We know our kids and families have a hard road ahead. Everything from reopening and recovering after the pandemic to dramatic reforms to our residential and mental health services will test the creaking and exhausted infrastructure upon which our kids rely.

But, in the last year, we saw the community step up to turn a tremendous threat into an opportunity for healing. More families received more support than ever before. Our work didn't slow down, but in fact redoubled.

We have you to thank for that. You share our vision of "For Every Child... A Place to Call Home." You, along with thousands of other parents, volunteers, donors, advocates, and professionals, believe

that no child should face the future alone. Thank you for connecting our kids so they can grow and heal.

There are enormous, intractable problems ahead in foster care, but you showed us over the past year that the biggest problems can be the greatest opportunities for progress. And, we promise you this: our vision, and the goals we set on the way to achieving it, will be as great as the needs of our kids.

After all, if you believed a home for every child was within your reach, is there anything you wouldn't do to make it happen?

lockdown, we launched the Coalition CareLine to quickly help foster, adoptive and guardianship families connect to services.

Within a week of Alicia had lost everything in a fire a few months before the pandemic stay-at-home orders went into effect. She is the primary caregiver for her two grandchildren in a very small house and was trying to piece together furniture for the home. Her hours were cut at her job due to COVID-19. She contacted the Coalition CareLine in desperate need for help to keep the family afloat during this time. The Coalition staff quickly provided wraparound support

to Alicia and her children. Alicia received a grocery gift card, as well as food pantry resources in her area that had events on days that she wasn't working. Staff also did a porch drop-off of clothing from ReFresh for Alicia's children. To ensure Alicia was connected to longerterm supports, Coalition staff helped her sign up to receive pandemic food stamp (P-EBT) benefits through the school system and provided guidance to navigate unemployment and

tax processes. The Coalition also connected Alicia with nonprofits in the area that helped her find furniture for her home. The Coalition CareLine support helped ensure Alicia and her kids' immediate needs were met. It helped reduce her stress levels and also gave her the confidence she needed to stay strong while navigating this difficult season of life.

Within a week of lockdown, we launched the Coalition CareLine to

quickly help foster, adoptive, and guardianship families connect to services. Our 2020 annual evaluation found we served an additional 781 families, made thousands of proactive calls to ensure families received benefits. and provided thousands of clothing items and masks to keep kids safe. Rather than widespread instability and further trauma, our families experienced unparalleled support. Your support over the years made that possible. The Coalition had the luxury of being agile, proactive, and intentional because thousands of individuals, foundations, corporations, and advocates have empowered us into a position to do so.

Due to consistent

demand for this kind of basic and material support, the Coalition will continue the CareLine through 2021. In addition to many of the same issues our families needed help with last year, we anticipate assisting foster, adoptive, and guardianship parents with P-EBT cards/food stamp sign-ups, housing and rental assistance applications, special broadband rates for families, and school uniforms and school supplies when kids return in the fall.

Thank you for helping us empower the families on the front line of foster care. Your support over the last year gave foster, adoptive, and guardianship families the resources they need to help their kids heal.

Making Birthdays Special: West County Center Partners with Coalition's Birthday Buddies Program

When officials with West County Center got word that many foster families were struggling during the pandemic, the shopping center went to work to find a way to help. Sean Phillips, the Marketing Director, came up with a very creative plan for the mall and its shoppers to support Birthday Buddies, an initiative of the Foster & Adoptive Care Coalition, so that all children in foster care would still be sure to receive birthday gifts and have happy birthday memories.

The mall installed an 8-foot-tall faux birthday cake, trimmed with envelopes labeled with the names of stores popular with kids. Shoppers simply pick up an envelope, write a birthday message on the enclosed card, drop in a gift card from one of the designated retailers, and insert the envelope into the opening on the cake. More than 110 gift cards were collected in the first month! Wow! We have been gratefully giving out these gift cards to children who were likely to receive nothing or almost nothing for their birthday. This year marks 20 years of the Foster & Adoptive Care Coalition's partnership with 5 on Your Side and "A Place to Call Home." In two decades, 464 children have found their forever families through "A Place to Call Home," and 79,249 Little Wishes have been granted to kids since our partnership began. 5 on Your Side is dedicated to driving transformative change in the community. This was especially evident as they found creative ways to continue featuring St. Louis children looking for families despite the challenges brought by the COVID-19 pandemic.

When social distancing guidelines went into effect, we could no longer safely go out in the community to film the kids for their "A Place to Call Home" segments.

This meant a big loss to

our recruitment programs. The "A Place to Call Home" segments not only provide an exciting and fun day for the children, but also serve as an important tool to reach

to keep telling our stories, so they worked quickly to get us up and running over Zoom. They brought in the wonderfully talented Anthony Slaughter to host our segments and help tell the stories of our kids looking for forever families."

"My favorite part is offering hope to these kiddos in finding a home," he said about hosting the zoom version of the A Place to Call Home segments. "Even just getting the word out to Slaughter:

"I think it's important to feature these wonderful children because a lot of times people who aren't affected by this can be blind to the need that exists. The kids in foster care didn't choose to be there, but with love and patience from a forever family, they can overcome their challenges, and in turn, become conquerors in their own life, and one day give back to help those in similar situations overcome as well. One thing I've learned in this life is that everything we go through is meant to help someone else. My belief is that in helping

Healthy Blue Missouri Makes \$60,000 Investment to Support Kinship Providers

Kinship providers are an invaluable resource in the process of getting children in foster care to permanency. Research shows that living with relatives is better for children and benefits them in several ways including reduction of trauma, decreasing negative mental health and behavioral issues, promoting sibling ties, and helping preserve children's cultural identity and relationship to their community. Kids placed with relatives are more likely to succeed in school, and less likely to be placed in often harmful and costly residential facilities.

We all saw through the struggles of the pandemic that connection and family mean everything.

Healthy Blue Missouri recognized this dire need


in our communities, and donated \$60,000 to support the kinship providers at the front-lines of foster care.

This funding assists families as they navigate the complex child welfare system, advocating for family and child needs, inhome services, and wraparound supports.

Hannah Trout, Families United Specialist at the Coalition, said of the program, "While families have natural supports, sometimes they just need to call someone who understands exactly what they're going through, and I'm happy to be that call. "

Policy Spotlight: State Rep **Kimberly-Ann Collins** Steps Up for Kids

Created in the 1990's

by African American foster parents who knew our community could do better, RESPOND led our region in recruiting African American foster parents to support the cultural needs of our youth. 70% of children in St. Louis foster care are Black, compared to 30% of our general population. With the blessing of RESPOND's founders, the Coalition seeks to bring the program back to combat this disparity and give every child access to a home which can meet their unique cultural needs.

How 30 Days to Family® Helped Tristan Find a Forever Home with His Fifth Cousin

Tristan came into care due to prenatal drug exposure. Scared and unsure of what to do next for their little boy, his parents left him at the hospital. He was there for weeks without visitors and upon discharge was placed in a traditional foster home.

Tristan's two older brothers, Trevor and Bryant, had come into foster care several years ago and were subsequently adopted by different families. Neither family was able to take Tristan into their homes.

Tristan's case manager referred him to the Coalition's 30 Day to Family® program, and Teara was assigned to the case.

Teara searched for family members who might be interested in a connection with Tristan. Several were upset when they were contacted because of their estranged relationship with Tristan's mom and dad. Tristan's maternal grandmother and paternal aunt could not provide placement, either.

During her search, Teara found 271 family members to add to Tristan's family tree. Finally, when Teara called Tristan's fifth cousin, Maleka, there was no hesitation before she said, "Yes!" She and her partner, Callie, had recently



discussed becoming foster parents. Maleka had been contacted years prior when Trevor and Bryant came into care, but she wasn't at a point in her life to take them into her home. That decision haunted her.

Due to COVID-19 precautions, Teara completed a safety walkthrough of the home virtually via Zoom. She found the home to be more than suitable for Tristan. They live near Maleka's sister and nieces and nephews, so not only would the family have support, but Tristan would get to grow up with some of his relatives. On top of that, Maleka works at a daycare that Tristan would be able to attend with her during the day.

After Tristan moved into the home, Teara referred Maleka and Callie to the Coalition's Families United program for licensing. Anne was assigned to the case and was quickly able to build rapport with the family, even though it was a virtual relationship. She enrolled the couple in virtual training through the Coalition and supported them throughout the licensure process. They were so eager to become Tristan's caregivers that they completed everything in record time. They were new

to foster parenting, so Anne spent a lot of time helping them understand the child welfare system and their role on Tristan's team of professionals.

Maleka and Callie were hesitant to reach out to the family members identified by Teara because of their complicated history, and their worry the experience with others would be the same. Anne spoke to them in-depth about the importance of familial connections, especially for youth in foster care. Anne's encouragement and guidance helped them contact family members, including maternal grandma and paternal aunt who initially reached out. They continue to speak regularly to Tristan's family as well as send pictures and updates.

Maleka and Callie love Tristan so much. They are amazing advocates and proactive about his growth and development. Tristan has completely integrated into their family and is thriving. His case plan has changed from reunification to adoption.
