A Place to Call Home: **Callie's Story**



Due to the pandemic, we had to move all of our A Place to Call Home stories online. 5 On Your Side was eager to keep telling our stories, so they worked quickly to get us up and running over Zoom. They brought in the wonderfully talented Anthony Slaughter to host our segments and help tell the stories of our kids looking for forever families. Concurrently, Vantage Credit Union stepped in to sponsor A Place to Call Home. We are beyond thankful for 5 On Your Side's agile response and Vantage Credit Union's dedication to ensuring A Place to Call Home would continue to air during this time.

This is the story of Callie, one of the hundreds of children whose life has been positively impacted by A Place to Call Home: At three and a half years old, Callie entered foster care due to domestic violence in her home. After her mom,

who struggled with untreated mental illness, tried to abduct Callie, her father gained limited custody. That tenuous placement wobbled for almost three more years before collapsing.

At six years old, Callie went to her first foster placement. Callie bounced between four different foster homes in less than three years. Her trauma made it hard for her to trust adults. The smallest thing could put her back in the worst moments of her life. Physical aggression, delayed social skills due to lack of interaction with other kids, and an intellectual disability made things hard for her at home and school. She was sent home often for biting, kicking, and spitting over reasons the teachers couldn't understand.

Finally, Callie was placed in a specialized therapeutic home. While this somewhat helped her behaviors, Callie's team saw her becoming a teenager in three short years. This made her especially high risk for "aging out" of foster care to harrowing odds of unemployment, homelessness, early pregnancy, and incarceration. Unsure of what to do, they called Extreme Recruitment®.

When Callie first entered care, her mother, battling a mental health crisis, was not able to work with the social workers who find family. So while dad's side of the family was well-known, mom's was not. Mike, a private investigator who works for the Coalition, quickly found 100 relatives no one had talked to. He introduced himself and shared Callie's A Place to Call Home video. It stirred their memory in a way a

decided their home would be perfect for Callie. Thomas, a pastor, and Sophia, a social worker, had adopted their niece just two months before. Sophia especially had talent and experience working with traumatized youth. They also had two adult sons, one of whom had a disability, giving them insight into raising differently-abled children. When they held their first Zoom meeting, Thomas and

her therapist and prepared the school and Callie's parents to secure her special services in the classroom. She also helped reestablish Callie's mental health services she had lost due to a clerical error.

Callie was officially adopted at the end of February. She has lived with Thomas, Sophia, and her new little sister for almost a year. With involved parents as advocates, she is thriving in school. After almost seven years of uncertainty, Callie finally has a chance to heal.



Amanda, an Extreme Recruiter® with the Coalition, quickly realized a source of stagnation in the case; the team wanted Callie's current foster mom to adopt her. However, Amanda was able to quickly assess it wasn't a good fit due to unrealistic expectations for a young girl with extreme trauma and an intellectual disability. She began to search for alternatives.

phone call simply doesn't. Even if they couldn't take Callie, many of her relatives offered names and introductions to others who they thought might.

Two months after Amanda started the case, she sent Callie's A Place to Call Home feature to Callie's maternal cousin Sophia and her husband Thomas. They immediately asked for a meeting. Amanda quickly


Sophia hadn't seen Callie in years. Sophia pulled out a photo album and began to show Callie pictures of her family. Callie was riveted; she didn't remember most of them because she was so young when she entered foster care.

As Callie prepared to move in, Amanda coordinated with the team so everything would be ready. She ensured Callie could keep

After two long years, we held our first family event in person! One little boy told

Creating the Most Supportive & Innovative **Foster Care & Adoption Community** in Our Country

The Foster & Adoptive Care Coalition held a series of “town hall” meetings with hundreds of local child welfare community members after learning that the State of Missouri is making a \$5 million investment to expand foster care and adoption services. These conversations helped the Coalition form a bold vision for changing the way children experience foster care in St. Louis. In close collaboration with our community partners, the Foster & Adoptive Care Coalition will expand our work for families in the following four areas.

1. Rapidly Increase the Number of Foster Parents. Every child in foster care will have a family who meets their unique cultural, behavioral, and emotional needs by expanding the number of African American, medical/behavioral, and respite foster homes. Grow capacity by 133%.

2. Permanent Families for Children as Quickly as Possible. Recognizing that every moment in foster care is too long, children will reach a permanent family as quickly as possible by reducing waitlists for 30 Days to Family® and Extreme Recruitment® and providing expanded family finding services to partner agencies. Grow capacity by 62%.

3. Wraparound Support & Training. Caregivers and professionals will have timely, effective access to the best support and training to meet children’s mental health and cultural needs, including the areas of trauma, transracial parenting, and LGBTQIA+ support. We will bolster services in rural, underserved counties. Grow capacity by 88%.



4. Tailored Services for Families & Older Youth. Ensure no child falls through the cracks by eliminating current wait lists for educational and mental health systems navigation, as well as crisis intervention and supporting older youth with housing and workforce development needs. Grow capacity by 62%.

To carry out this work, the Coalition staff will grow substantially with new supervisory, program, and administrative staff across all teams to ensure every foster, adoptive, and guardianship family in St. Louis has the support they need to help kids heal.

The Coalition is Hiring

After continuous, steady growth, the Foster & Adoptive Care Coalition will nearly double in size thanks to additional funding from the State of Missouri. A Record-breaking Jr. Board Trivia Night



30 Days to Family®:

Rayna, Jasmine & Charlie

In September, 12-year-old Rayna, 4-year-old Jasmine, and 3-year-old Charlie entered foster care after their parents struggled to provide adequate supervision. They were initially placed in a foster home and Joel, 30 Days to Family® Specialist, was assigned to the case.

Joel spoke with children's mother who mentioned 10 relatives that Joel could look into, including a maternal grandmother, Caprice. Joel discussed those family members with Rayna to see if she had any thoughts on where she would like to be placed. Rayna told him that she would like to be placed with Caprice because her older sister, 16-year-old Becca, lived there, and they

spent most weekends there anyway.

Caprice did not hesitate to accept placement of Rayna, Jasmine, and Charlie. She was not only raising Becca, but she also raised two of their older brothers until they were old enough to live on their own. A walk-through of the home and thorough background checks were completed. The team spent some time considering Caprice's capacity to care for three additional children. They decided it was in the children's best interest to live with Caprice and their older sister. Joel advocated for Caprice to receive Urgent Needs Funding from the Coalition to purchase a fire extinguisher which is needed

for foster parent licensure. Caprice lived in the same school district that Rayna attended, so there was continuity in Rayna's education which is paramount in limiting the impact of trauma caused when children enter foster care. They were placed with Caprice within 22 days of coming into foster care.

Even though Joel found Caprice, he continued to look for more family. Caprice was worried Joel would find someone else to care for her grandchildren, and she would lose contact with them. Joel spent time building a relationship with Caprice to assure her he was trying to build up a network for her to have a

support system as well as find potential backup options in case anything should happen to Caprice. She trusted Joel and provided information for family members Joel could contact. Joel's list of relatives went from 6 at the beginning of the case to 150. He personally spoke to 20 family members; most of them lived close by and were eager to help.

Joel visited with Caprice, Rayna, Jasmine, Charlie, and Becca in December. He dropped off Christmas gifts for them: art supplies and a big sack of toys. The children seemed happy and loved. Joel could tell they were right where they needed to be.





Celebrating the Legacy of **Mr. Richard H. Patton, Jr.**

Our Coalition family is mourning the loss of one of our former leaders, a tireless advocate for children in St. Louis, and a kind, generous soul, Mr. Richard H. Patton, Jr.

As former President of our Board of Directors, Mr. Patton helped set us on the path we are still on today: intentionally seeking out unmet needs in our

community so no child falls through the cracks. His connections in the child welfare community helped advance key partnerships and create a culture of collaboration we still treasure.

Lottie Wade helped coordinate the founding of the Foster & Adoptive Care Coalition and worked with Mr. Patton on numerous child welfare issues. She remembered his warmth and kindness: “He was a quiet leader – you could count on him for data, you could count on him

to show up. After long meetings, some of us would start to fidget but he never lost his ability to listen. And he had such a wonderful sense of humor.”

Mr. Patton’s awards, accolades, and accomplishments are too numerous to list here; he worked his entire life to achieve justice and well-being for kids in St. Louis. As a founder and leader of Vision for Children at Risk, Mr. Patton not only impacted the kids and families we serve, but so many of the professionals who share our mission. As

such, Mr. Patton’s legacy is so much more than his many accomplishments. He set an enduring example of solidarity and selfless service.

Wanda Stokes, who also worked with Mr. Patton on the Coalition’s Board, summarized his service as a leader: “He was the connector, always making sure we got in touch with the people we needed. He was kind and gentle, and he got things done.”

The entire Coalition Family is sorry for the loss of a great leader in our community, yet grateful for the example he set and the time and talent he gave to us all.

Rebooting the **RESPOND** Program



We are so proud to be rebooting the RESPOND program, a project created by Howard and Vickie Denson in the early 90's to address the shortage of African American foster parents. The overrepresentation of African American children in foster care and the lack of culturally appropriate homes are still present today. With the support of the Missouri Legislature and Representative Kimberly-Ann Collins, who spearheaded making sure RESPOND was in the budget, we are here today reopening the RESPOND program to best serve our kids.

We know we can't do this work alone. We reached out to the community and developed an advisory committee and focus groups to support not just the launch but to build trust and genuine connections with the

community. This advisory committee consists of 18 professionals including community volunteers, stakeholders, corporations, funders, and Governing and Junior Board Members. The RESPOND Advisory Committee Members are:

RESPOND over a 3-year term and hired Jasmine Evans, a marketing consultant, to help create a brand that resonates with our community.
