Little Wishes Holiday Program: Deadline October 15

It's time to register online or over-the-phone for the Little Wishes holiday program! Thanks to KSDK 5 On Your Side and thousands of generous donors, you can register your children impacted by foster care to receive special holiday gifts.

Children are eligible if they live in St. Louis City or the MO counties of St. Louis, Jefferson, St. Charles, Lincoln, Franklin, or Warren and are currently in the foster care system, or were in foster care and now live in one of these counties with their adoptive or guardianship family.

Step 1:

Locate your **Coalition Caregiver ID**, which can be found above your address on the outside of this newsletter.

Step 2:

Find a safe address to provide for gift delivery. Some shippers leave boxes at the front door! We receive calls every year from caregivers who didn't receive gifts that were shipped to them. Unfortunately, we can't replace gifts that were delivered. Note: please do not use a P.O. Box number—some shippers require an actual address.

Step 3:

To submit a request, you'll need to provide the name and phone number for each child's **current foster care case manager or adoption/guardianship subsidy worker**. We WILL verify this information.

Step 4:

Choose gifts!

- Youth currently in foster care who are under 8 years old may request 1 gift from the white sheets of the catalog
- Youth currently in foster care who are 8-20 years old should request 1 gift from the white sheets and 1 gift from the blue sheet of the catalog
- Youth who live with their adoptive/guardianship family may request 1 gift from the white sheets of the catalog (until their 18th birthday)

Step 5:

Submit your wish requests.

Submitting your own wish requests online is preferred! It's easy and helps avoid errors! Go to:

foster-adopt.org/wish

What if I can't submit my gift request online?

If you cannot submit your gift requests online, please register by phone during our three phone registration days: Tuesday, October 7, Tuesday, October 14, or Wednesday, October 15, 9 a.m.–5 p.m. at (314) FOSTER-3.

If online and phone registration are not possible, you can fill out the enclosed form and send it back to us. If you mail in your referral form and it is filled out incorrectly or if inappropriate gifts are chosen, we will select age-appropriate gifts for the child.

Register for Motion for Kids Party

Each December, the Bar Association of St. Louis throws a fun holiday party for families in the St. Louis region. For years, our families have enjoyed an event filled with gifts, activities, and lots of joy. Each child registered for the event requests one gift. Motion for Kids donors purchase these gifts for families to pick up at the party!

Motion for Kids will be hosting this year's party on Saturday, December 6, 10 a.m.–noon.

Who can register?

You must be a family with foster/adopted/guardianship children who are 17 years old or younger. **Only people living in your household may attend.**

When can I register?

Registration is by phone only. It starts on **Friday, October 3** and continues on **Monday, October 6** and **Tuesday, October 7** until all spots are filled.

How do I register?

Call (314) FOSTER-3 **between 9:00–5:00 p.m.** on the registration dates listed. Spots are limited and filled on a first come, first served basis! We will not take registrations by voicemail or email. **Tip:** For the first few hours on the first day, we are always flooded with calls! It can be very difficult to get through. Please anticipate long wait times, and we will answer your call as soon as we can. If you experience this on Friday, October 3, please try calling again later on Friday afternoon or on Monday morning.

What do I need to register?

When you call, you must have a specific gift request priced around **\$50** for each child. Be specific, including brands, titles, and sizing: (i.e. "Lego Minecraft set" or "Boys t-shirt, red or black, Nike or Adidas, size Youth 10-12"). This helps the donors know exactly what to get your child. **Gift card or cash requests are NOT accepted.**

What if I can't attend the event?

All gifts must be picked up at the event, no exceptions.

Crime Victims' Compensation Program

Purpose

The Crime Victims' Compensation program provides monetary support to eligible individuals and their family members who are victims of certain violent crimes.

Eligibility

Basic criteria required to determine eligibility include:

1. Crime must have occurred in Missouri
2. Crime must be reported to the proper authorities
3. Victim/claimant must cooperate with law enforcement
4. Victim must not have contributed to their injury
5. Victim must not have been in the commission of a crime
6. Application must be received within two (2) years of the date of the crime or discovery of the crime
7. An arrest or conviction of a suspect is not required

Allowable costs

Allowable benefits may include medical, funeral and counseling expenses, lost wages or loss of support for eligible victims and their family members. Professional service providers are paid directly for eligible crime service. If victim/claimant has paid out-of-pocket they may be reimbursed, if eligible. The maximum benefit levels are \$5,000 for funeral expenses and up to \$400/per week for lost wages. The total maximum benefit is \$25,000.
